Purpose of the Job: This role is primarily responsible for overall coordination of shift operations, allocating and prioritizing utilization of available resources optimally to ensure maximum productivity, and prompt decision making in emergency situations thereby ensuring that safety, health and environmental norms are adhered to. This role requires to interact with statutory agencies, general public during any eventualities. This role needs to take the chief emergency controller position during silent hours till the designated chief controller arrives at site

Overview/ Responsibilities: As a Sr Manager Production, you will be expected to:

To manage overall operational activities of Terminal in shifts: Timeliness / Demurrages / Delays	Monitoring & controlling of all the activities i.e To carry out unloading & loading of Phosphoric acid & Ammonia with in stipulated time from Ship & Road Tankers & other Terminal operations including Repair & Maintenance of all the related equipments to keep the system in healthy working condition all the time.
Safety, Health & Environmental aspects: No of Incidents.	Ensuring all the activities of the Terminal operation are being carried out by following Safe Operating Procedures. Safe handling of Product & Equipments using required PPEs.

Discipline: No of Interruptions / Scarcities.	To monitor & Review Disciplinary aspects as per policies laid by Management.
Up keeping of system / Equipments: Break downs.	Ensuring minimum downtime of equipment by prioritising the maintenance requirements of the System , and instructing the maintenance team accordingly so that preference is given to jobs which are critical and require prompt handling.
Handling Emergencies: Response time / Efficiency in Co ordinations	Avoiding hazardous and disastrous situations by acting as the chief emergency site controller in case of emergency situations ,till the emergency controller arrives on site after which he will take over as the incident controller and during this process he will coordinate with local authorities and make external help available if necessary to control the emergency situation.
Governing Statutory compliances: Non-Compliance.	Ensuring that all safety systems are being implemented, all statutory norms are being met with regards to effluent discharge from the Terminal, and all other reasonable measures are being taken to prevent non compliances so as not to attract any legal implications.
