- Supervise Quality checking of RM, PM, Intermediates product, FG as per the specification and standards at K7/K8/ JNPT site.
- Execute job planning for laboratory activities for shift and general shift
- Ensure checking and certification of all finished products.
- Ensure checking of raw materials.
- Control inventory of all costly instrument spares and ensure availability of all essentials and consumables like glassware, chemicals, bulbs, electrodes, conductivity cells, laboratory spares & consumables, stationery etc.
- Ensure regular calibration of laboratory instruments like Spectrophotometers, Conductivity meters, pH meters, flow meters etc. using relevant standards.
- Ensure daily entry of above work analysis and verification.
- Ensure entry of raw-materials data, packaging material tested in laboratory in SAP.
- Issue of relevant quality certificates.
- Ensure preparation of indents & store issue slip for laboratory through SAP.
- Analyse samples received from the Marketing Department and submit reports.
